RESOLUTION 05-03-95-93

WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is

A RESOLUTION GRANTING A LAND LEASE TO

- the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;
- WHEREAS, a tribal land lease is needed for the purpose of homesites on tribal lands for the Mille Lacs Reservation, and;
- WHEREAS, the lease will be for a period of 25 years plus 25 years effective March 3, 1993 for the purpose of a homesite, and;
- WHEREAS, said land is described as follows: That part of the S 1/2 of SE 1/4 SW 1/4 of Section 7, Twp. 43N, Range 27W, Kathio Township North, Mille Lacs County, State of Minnesota. Beginning at the section line post marker on Hwy. 2, thence West 200 feet, thence South 200 feet, thence East 200 feet, thence North 200 feet, parallel with the North boundary along the waters edge of Whitefish Lake.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to for a period of 25 years plus 25 years renewal effective on March 3, 1993.
- BE IT FURTHER RESOLVED, that lease will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.
- BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the leasee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the <u>3rd</u> day of March, 1993 at Vineland, Minnesota by a vote of <u>2</u> FOR, <u>0</u> AGAINST, <u>0</u> SILENT.
- IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the hand of the Speaker of Assembly to be affixed to this resolution.
