RESOLUTION 05-03-91-93

A RESOLUTION AMENDING LAND LEASE AGREEMENT DESCRIPTION FOR [REDACTED]  
[REDACTED] (RESOLUTION 55-84).

WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;

WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;

WHEREAS, a tribal land lease is needed for the purpose of homesites on tribal lands for the Mille Lacs Reservation, and;

WHEREAS, the lease will be for a period of 25 years plus 25 years effective March 3, 1993 for the purpose of a homesite, and;

WHEREAS, said land is described as follows: That part of Gov't Lot 8, Johnstons Rearrangement of Part of Gov't Lot 4, on file and of record in the office of the County Recorder, Mille Lacs County, Minnesota, described as follows: Commencing at the Southwest corner of said Lot 8, thence North 89 degrees 29 minutes 14 seconds East (bearing assumed) along the South line of said Lot 8, a distance of 333.91 ft. to point of beginning, of the land to be described, thence North 0 degrees 13 minutes 42 seconds East, a distance of 95.41 feet, thence North 25 degrees 00 minutes 21 seconds West a distance of 57.50 feet, thence South 89 degrees 29 minutes 14 seconds West, a distance of 123.00 feet to a point, thence South 0 degrees 13 minutes 42 seconds West, approximately 150 feet to the South line of Lot 8, thence North 89 degrees 29 minutes 14 seconds East approximately 150.00 feet to the point of beginning containing .50 acres more or less.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective March 3, 1993.

BE IT FURTHER RESOLVED, that lessee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.


BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 3rd day of March, 1993 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
