RESOLUTION 05-03-103-93

	A RESOLUTION GRANTING A LAND LEASE TO
WHEREAS,	the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
WHEREAS,	wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;
WHEREAS,	a tribal land lease is needed for the purpose of homesites on tribal lands for the Mille Lacs Reservation, and;
WHEREAS,	the lease will be for a period of 25 years plus 25 years effective March $\underline{10}$, 199 for the purpose of a homesite, and;
WHEREAS,	said land is described as follows: that part of Section 17, Twp. 43N, Range 27W starting at the intersection of approach and the centerline of Hwy. 169, hence a distance north down the centerline of a drivewa a distance of 300 feet to the point of beginning, hence due east a distance of approximately 150 feet to the east section line of Section 17, hence South a distance of 250 feet along said section line, hence due west to the centerline of driveway, hence north along said centerline to point of beginning (Parcel B).
NOW, THEREFO	ORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a least to be issued to the form of the period of 25 years plus 25 years renewal effective on March $10 \mathrm{th}$, 1993.
BE IT FURTHER	RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.
BE IT FURTHER	& FINALLY RESOLVED, that this lease shall be null and void should the leasee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.
WE DO HEREB	Y CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the $\underline{10}$ day of March, 1993 at Vineland, Minnesota by a vote of $\underline{3}$ FOR, $\underline{0}$ AGAINST, $\underline{0}$ SILENT.
