RESOLUTION 05-03-80-93

A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]

WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;

WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;

WHEREAS, a tribal land lease is needed for the purpose of homesites on tribal lands for the Mille Lacs Reservation, and;

WHEREAS, the lease will be for a period of 25 years plus 25 years effective February 11, 1993 for the purpose of a homesite, and;

WHEREAS, said land is described as follows: Section 32, Township 49N, Range 23W, Beginning at the center line of Hwy. 6, 33 ft. South of intersection of Hwy. 6 and gravel drive, go 74.115 ft. to NE corner of Lot 1, thence 267.19 ft. West to the NW corner, thence South 200 ft. to the Sw corner of Lot 1, thence 122.16 ft. East to the SE corner of Lot 1, thence North 37 degrees 10 minutes 48 seconds East to point of beginning All East and West bearing are 88 degrees 46 minutes .05 seconds, Atiken County.


NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective February 11, 1993.

BE IT FURTHER RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.

BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the leasee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.


