	A RESOLUTION DELETING NAME (DECEASED) FROM LAND LEASE (RESOLUTION 17-80) ISSUED TO
WHEREAS,	the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
WHEREAS,	the Mille Lacs Band Assembly is responsible for all land lease agreements, and;
WHEREAS,	were issued a land lease (Resolution 17-80) for a lot on the Mille Lacs Reservation for the purpose of a homesite, and;
WHEREAS,	tribal land leases are needed for the purpose of a homesite on tribal land for the Mille Lacs Reservation, and;
WHEREAS,	said land is described as follows: Beginning at the Southeast corner of the SE 1/4 of the NE 1/4 thence 180 ft. North to the point of beginning, thence 80 ft. West, thence 200 ft. North, thence 80 ft. East, thence 200 ft. South to the point of beginning in Section 28, and beginning at the Southwest corner of the SW 1/4 of the NW 1/4, thence 180 ft. North to point of beginning, thence 20 ft. East, thence 200 ft. North, thence 20 ft. West, thence 200 ft. South to point of beginning in Section 27, Township 43N, Range 27W in Mille Lacs County, State of Mn., Vineland Hills.
NOW, THEREFO	ORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves name to be stricken from land lease issued and for land lease to remain in name only.
WE DO HEREBY	Y CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the $\frac{2nd}{}$ day of February, 1993 at Vineland, Minnesota by a vote of $\frac{3}{}$ FOR, $\frac{0}{}$ AGAINST, $\frac{0}{}$ SILENT.
