RESOLUTION 05-02-19-93

A RESOLUTION GRANTING A LAND LEASE TO

wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and: WHEREAS. a tribal land lease is needed for the purpose of a homesite on tribal land for the Mille Lacs Reservation: and. WHEREAS. said land is described as follows: A parcel of land in the South half of the Southeast quarter (S 1/2 of SE 1/4) of Section 27, Twp. 42 North, Range 26 West. Described as follows: Beginning at a point on the South Section line of said Section. 27, one thousand four hundred twenty feet (1,420) West of the Southeast corner of Section 27, thence North three hundred thirty (330) feet; thence West and parallel to the Section line, three hundred ninety six (396) feet; thence South and parallel to the East line, three hundred thirty (330) feet to the Section line; thence East on and along said Section line three hundred ninety six (396) feet to the point of beginning containing 3.0 acres. Land deeded to Mille Lacs Band of Chippewa Indians on August 12, 1992 by a quit claim deed. WHEREAS. the lease will have to be for a period of 25 years plus 25 years effective October 30, 1992 for the purpose of a homesite. NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease be issued to for a period of 25 years plus 25 years renewal effective BE IT FURTHER RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band. BE IT FURTHER AND FINALLY RESOLVED, that this lease shall be null and void should the leasee abandon or vacate the above described property for more than thirty days without prior approval of the Band Assembly. WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative council assembled, a quorum of Legislators being present held on the 30th day of October, Vineland, Minnesota by a vote of 2 FOR.0 AGAINST, 0 SILENT. IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the hand of the Speaker of Assembly to be affixed to this resolution. avid Matrious, Speaker of Assembly
