RESOLUTION 05-04-197-93

A RESOLUTION GRANTING THE RELINQUISHMENT OF A ENROLLED MEMBER OF THE MILLE LACS BAND, MILLE LACS RESERVATION.

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Reservation, and;

WHEREAS, the Mille Lacs Band Assembly has screened the following applications for relinquishment, and;

have signed a relinquishment form with the Minnesota Chippewa Tribe and relinquishes and surrenders any and all rights, title and interest that they may have in any undistributed property and assets of the Mille Lacs Band, Mille Lacs Reservation of the Minnesota Chippewa Tribe, and;

WHEREAS, information received by the St. Croix Tribal Council states their Tribal Council will accept Junior A. Staples, Russell Merrill, Raymond Merrill, Thomas Bugg III, and James Merrill for membership providing that relinquishment is certified by the Minnesota Chippewa Tribe and the Mille Lacs Band, Mille Lacs Reservation.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does determine that this relinquishment is proper and that the interest of the individuals have been considered and that these individuals do meet the requirements for membership with the St. Croix Tribe and does approve the granting of the relinquishment for Junior A. Staples, Russell Merrill, Raymond Merrill, Thomas Bugg III and James Merrill.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 4th day of October, 1993 at East Lake, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
