## **RESOLUTION 05-04-17-94**

A RESOLUTION IN SUPPORT OF THE SUBMISSION OF PROPOSAL TO THE UNITED STATES DEPARTMENT OF JUSTICE, BUREAU OF JUSTICE ASSISTANCE, FOR THE POLICE HIRING SUPPLEMENT PROGRAM.

- WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, the Mille Lacs Band is desirous to improve and protect the safety and well being of Band members, as well as the general public, on lands under the jurisdiction of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, the Mille Lacs Band Assembly respectfully requests funding for police officers, to expand and improve law enforcement efforts in effect on the Mille Lacs Reservation.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Chippewa Indians does hereby approve and authorize the submission of a proposal for assistance to the United States Department of Justice, Bureau of Justice Assistance, for the Police Hiring Supplement Program.
- BE IT FURTHER RESOLVED, that the Commissioner of Administration and the Chief Law Enforcement Officer are authorized to sign on behalf of the Mille Lacs Band of Chippewa Indians.
- BE IT FURTHER & FINALLY RESOLVED, that in the absence of the Commissioner of Administration, it is hereby authorized that the Assistant Commissioner of Administration be authorized to sign on behalf of the Commissioner of Administration.
- IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the hand of the Chief Executive to this resolution and forwarded to the Band Assembly for concurrence.
