## **RESOLUTION 06-01-43-94**

A RESOLUTION FROM THE MILLE LACS BAND OF CHIPPEWA INDIANS AUTHORIZING SUBMISSION OF PROPOSAL TO THE UNITED STATES DEPARTMENT OF HEALTH & HUMAN SERVICES FOR FUNDING UNDER THE JOBS PROGRAM OF THE FAMILY SUPPORT ACT OF 1988 (P.L. 100-485).

- WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, the Mille Lacs Band recognizes that traditionally high unemployment rates in the Mille Lacs Indian community have caused very serious social and economic problems, along with other forms of extreme hardship for the residents of the Mille Lacs Indian community, and;
- WHEREAS, the Mille Lacs Band will operate its Project STRIDE program within the service delivery area consisting of the Minnesota counties of Aitkin, Benton, Crow Wing, Mille Lacs, Morrison and Pine, and;
- WHEREAS, it has been determined that such resources administered by the Tribal Employment & Training Department of the Tribal Government can indeed help lessen the negative effects of long-term Welfare dependency, and;
- WHEREAS, create a self-growth, independence, and self-sufficiency among residents of the Mille Lacs Indian community, and;
- WHEREAS, the Commissioner of Administration is authorized under Band Statute 2002-MLC-3 to negotiate and execute agreements, contracts, cooperative and reciprocity agreements, memoranda of understanding for the benefits of the general welfare of the people of the Mille Lacs Band of Chippewa Indians.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly recognizes the need for Employment and Training activities consistent with the intent of the Family Support Act of 1988 P.L. 100-485 and any subsequent amendments issued by the federal and/or state guidelines. It is the intent of the Band to operate the Tribal JOBS/STRIDE Program to support employability growth of the individual receiving AFDC, leading to self-sufficiency.
- BE IT FURTHER & FINALLY RESOLVED, that the Mille Lacs Band of Chippewa Indians designates the Executive Branch as the unit of Band Government to administer and conduct programming under the JOBS/STRIDE Program.
- IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the signature of the Chief Executive to this resolution and forwarded to the Band Assembly for concurrence.
