RESOLUTION 06-01-70-94

A RESOLUTION GRANTING THE RELINQUISHMENT OF ENROLLED MEMBERS OF THE MILLE LACS BAND, MILLE LACS RESERVATION.

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Reservation, and;

WHEREAS, the Mille Lacs Band Assembly has screened the following applications for relinquishment, and;

have signed a relinquishment form with the Minnesota Chippewa Tribe and relinquishes and surrenders any and all rights, title and interest that they may have in any undistributed property and assets of the Mille Lacs Band, Mille Lacs Reservation of the Minnesota Chippewa Tribe, and;

WHEREAS, information received by the St. Croix Tribal Council states their Tribal Council will accept the above mentioned individuals for membership providing that relinquishment is certified by the Minnesota Chippewa Tribe and the Mille Lacs Band, Mille Lacs Reservation.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does determine that these relinquishments are proper and that the interest of the individuals have been considered and that these individuals do meet the requirements for membership with the St. Croix Tribe and does approve the granting of the relinquishment for Gladys Bearheart, Edwin A. Benjamin, Leona L. Garbow, Betty M. Torgerud and Shirley Wegan.


