RESOLUTION 06-01-69-94

A RESOLUTION REQUESTING THAT THE BUREAU OF INDIAN AFFAIRS PLACE LAND IN TRUST FOR THE MILLE LACS BAND OF OJIBWE.

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, and;
- WHEREAS, the Mille Lacs Band of Ojibwe have acquired land within exterior boundaries of the Mille Lacs Reservation for housing and expanded land base, and;
- WHEREAS, the Mille Lacs Band of Ojibwe wishes to put these lands transferred to the United States in trust for the Mille Lacs Band of Ojibwe.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band of Ojibwe is hereby requesting the Bureau of Indian Affairs to accept the following land to be put in trust:

Parcel 1: Commencing at the iron monument on the shore of Lake Mille Lacs located in the Northwest corner of Government Lot three (3), Section Seventeen (17), Township Forty-three (43), Range Twenty seven (27), thence running South along the western boundary line of said Lot Three (3), thirty-eight (38) rods; thence Easterly at right angles thirty-four (34) rods, thence northerly to the iron monument on the shore of Mille Lacs Lake to the point of beginning, except highway.

Parcel 2: That part of the South fourteen (14) rods of the West thirty-four (34) rods of said Government Lot Three (3) lying Northeasterly of the right of way of State Highway 169, containing .66 acres more or less.

All those parts of Government Lot 3, Section 17, Township 43 North, Range 27 West of the 4th principal meridian. Mille Lacs County, Minnesota described as follows: Commencing at point 1306 feet, more or less, North and 1861 feet, more or less. East of corner to Section 17, 18, 19 and 20 in said Township and Range, which said point is 34 rods East of the southwest corner of said Lot 3 and on the South line thereof; thence East 220 5/12 feet; thence North 627 feet; thence North 70 1/2 degrees West 247 1/2 feet to the Northeast corner of the Martin Gilbertson tract of land; thence South 709 1/2 feet to the point of beginning, and;

The West 100 feet of the East 534 feet of Lot 3, Section 17, Township 43, Range 27; less .20 acres to Highway. (All together approximately 5-plus acres having 347 5/12 waterfront feet) in the county of Mille Lacs, State of Minnesota.

- Exhibit A: Parcel 3 That part of Government Lot 3, Section 17, Township 43, Range 27, Mille Lacs county, Minnesota, described as follows: Commencing at the Brass Capped Monument at the southwest corner of said Government Lot 3; thence north 89 degrees 40 minutes 31 seconds east, assumed bearing, 879.60 feet along the south line of said Government Lot 3 to an Iron Monument, the point of beginning; thence North 89 degrees 40 minutes 31 seconds east 99.88 feet continuing along the south line of said Government Lot 3 to an Iron Monument; thence North 0 degrees 49 minutes 57 seconds west 573.94 feet to an Iron Monument; thence continuing North 0 degrees 49 minutes 57 seconds west 17 feet; more or less, to the shore of Mille Lacs Lake; thence westerly along said shore to its intersection with a line bearing north 0 degrees 38 minutes 18 seconds west from the point of beginning; thence south 0 degrees 38 minutes 18 seconds east 10 feet, more or less, to an Iron Monument that is north 0 degrees 38 minutes 18 seconds west 593.66 feet from the point of beginning; thence continuing north 0 degrees 38 minutes 18 seconds east 593.66 feet to the point of beginning. Subject to the right of way for county state aid highway number 35 and also subject to any other easements, reservation or restrictions of record.
- Exhibit B: Parcel 4 That portion of the East 234 feet of Government Lot three (3), Section Seventeen (17), Township forty-three (43), Range twenty-seven (27), described as follows: Beginning at a point where the West boundary line of said East 234 feet of said Government Lot Three (3) intersects with the center of Highway No. 169; thence South parallel to the West line of said Government Lot 3 for a distance of 207 feet; thence East parallel with the South line of said Government Lot 3 a distance of 126 feet; thence North parallel with the East line of said Government Lot 3 to the meander shore line of Mille Lacs Lake; thence West along the meander shore line of Mille Lacs Lake to a point on said meander shore line which is due north of the point of beginning; thence South parallel with the East line of said Government Lot 3 to the point of beginning, excepting therefrom existing highway.
- Exhibit C: Parcel 5 The West 3/4 of the Southeast Quarter of Southeast Quarter (SE 1/4 of SE 1/4) of Section Seventeen (17), Township Forty-three (43), Range Twenty-seven (27) and Government Lot One (1), except Maple Bank according to the plat thereof on file and of record in the Office of the Register of Deeds in and for Mille Lacs County, Minnesota and also excepting therefrom all that parcel of land lying South and West of Maple Bank and North of Trunk Highway No. 169 in Section Seventeen (17) of North Half of Kathio Township described as follows: Commencing at the Southeast corner of Maple Bank, thence running South on West line of Forest Drive a distance of 1024.8 feet to a point on North line of trunk highway right of way limits; thence in a Northwesternly direction and following the North right of way line of trunk highway a distance of 1326 feet to a point intersecting with the South line of Maple Lane extended; thence in a Northeasterly direction and connecting at Northwest corner of Lot 12, Block 3, a distance of 733.4 feet, said line being an extension of South side of Maple Lane, thence in a Southeasterly direction on the West line of Lot 12, a distance of 150 feet to a point, thence in a Northeasterly direction and on the South boundary line of Maple Bank a distance of 539.1 feet to a point of beginning, containing 15.5 acres, more

or less, and also excepting therefrom the tract described as follows: Commencing 400 feet West from the Southwest corner of Lot 7 of Block 2, of Maple Bank, thence in a Northwesterly direction 152 feet; thence in a Southwesterly direction along the shore of Mille Lacs Lake, 300 feet; thence in a Southeasterly direction 202 feet; thence in a Northeasterly direction 300 feet to a point of beginning, and also excepting therefrom the following described tract of land: Commencing at the Southwest corner of Lot 7, Block 2, of Maple Bank, thence in a Northwesterly direction along the West line of said Lot 7, a distance of 152 feet to a point; thence in a Southwesterly direction along the shore of Mille Lacs Lake a distance of 400 feet; thence in a Southeasterly direction parallel to the West line of Lot 7, a distance of 152 feet to a point, thence in a Northeasterly direction a distance of 400 feet to point of beginning, this tract containing 1.4 acres more or less, said Government Lot 1 being in Section 17, Township 43, Range 27. And also of Government Lot 2, excepting the West 144 feet thereof, in Section 17, Township 43, Range 27, and excepting also the South 432 feet of the East 251 feet of the West 395 feet of said Government Lot 2, Section 17, Township 43, Range 27; and also excepting the following described tract, to-wit: that part of Government Lots One (1) and Two (2), Section 17, Township 43, Range 27, Mille Lacs County, Minnesota, described as follows: Commencing at a point on the extension Southwesterly of the Northerly line of Maple Lane 700 feet Southwesterly from Southwesterly corner, also the most Southerly corner of Lot 7, Block 2, Maple Bank as platted, this point to be hereafter known as point A; thence Northwesterly at right angle to the shore of Mille Lacs Lake and the point of beginning of the land to be described; thence return to point A; thence Southwesterly along said extended Northerly line to the Northerly right of way line of Old U.S. Highway No. 169; thence Northwesterly along said Northerly line, which is on a curve with a delta angle of 25 degrees and 27 minutes and a radius is 954.31 feet, a distance of 310.91 feet; thence Northeasterly at right angle to the chord of the last described curve distance to the shore of Mille Lacs Lake; thence Northeasterly along said shore line to the point of beginning, Mille Lacs County, Minnesota.

Exhibit D: Parcel 6 Government Lot Four (4) and the Southwest Quarter of the Southwest Quarter (SW 1/4 of SW 1/4), and; Lot 1 & 2 of Block "A" of Westmere, being located in Section 21, Township 43, Range 27.
