	A RESOLUTION PERTAINING TO TERMINATION OF LAND LEASE AGREEMENT FOR RESOLUTION 05-02-84-92).
WHEREAS,	the Mille Lacs Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
WHEREAS,	the Mille Lacs Band Assembly is responsible for all land lease agreements, and;
WHEREAS,	the Mille Lacs Band Assembly hereby terminates  land lease agreement for the following land lease description: All that part of Indian Allotments No.s 36, 37, 71 and 72, Section 27, Township 43, Range 27, Mille Lacs County, Minnesota, described as follows: Commencing at a found Brass Cap Monument at the west quarter corner of said Section 27; thence North 89 degrees 56 min- utes 58 seconds East, assumed bearing along the south line of the Southwest Quarter of the Northwest Quarter of said Section 27, a distance of 797.67 feet to a point at the intersection of said south line of the Southwest Quarter of the Northwest Quarter of said Section 27 and the north line of Garbow's Road, as the same now exists, said point also being on the south line of said Indian Allot- ment No. 71; thence North 0 degrees 23 minutes 35 seconds West a distance of 180.00 feet; thence North 89 degrees 56 minutes 58 seconds East a distance of 148.86 feet to the point of beginning of the lot to be described; thence continuing North 89 degrees 56 minutes 58 seconds East a distance of 97.25 feet; thence South 16 degree 08 minutes 26 seconds East a distance of 185.33 feet to the north line of said Garbow's Road; thence westerly along said north line on a curve concave to the north a distance of 150.00 feet, said curve having a radius of 539.96 feet, a central angle of 15 degrees 55 minutes 00 second and a chord which bears South 81 degrees 49 minutes 05 seconds West; thence North 0 degrees 13 minutes 26 seconds West a distance of 199.22 feet to the point of beginning.
NOW, THERE	FORE, BE IT RESOLVED, that the Mille Lacs Band of Chippewa Indians hereby terminates this land lease agreement effective February <u>1st</u> , 1994
WE DO HERE	BY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the <a href="lst">1st</a> day of February, 1994 at Hinckley, Minnesota by a vote of <a href="mailto:3">3</a> FOR, <a href="mailto:0">0</a> AGAINST, <a href="mailto:0">0</a> SILENT.
