RESOLUTION 05-04-23-94

A RESOLUTION FROM THE MILLE LACS BAND OF CHIPPEWA INDIANS IN SUPPORT OF THE CANDIDACY OF MARGE ANDERSON, CHIEF EXECUTIVE, FOR THE POSITION OF MINNEAPOLIS AREA REPRESENTATIVE, WITH THE NATIONAL CONGRESS OF AMERICAN INDIANS.

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;

WHEREAS, the Band Assembly of the Mille Lacs Band of Ojibwe Indians supports the mission of the National Congress of American Indians, which is to provide a national forum for federally recognized American Indian tribes to consider and take positions on federal Indian policy and legislative issues, and;

WHEREAS, the Band Assembly of the Mille Lacs Band of Ojibwe Indians believes that better communication is needed between the NCAI Member tribes of the Minneapolis Area Office and the NCAI Washington Office, to ensure that Minneapolis Area Tribes are well informed about legislative issues, and;

WHEREAS, National issues are of such importance to the Mille Lacs Band of Ojibwe that in 1993 the Band opened a tribal office in Washington D.C. for the express purpose of ensuring that the Band is informed about national issues and has a presence in the Nation's Capitol, and;

WHEREAS, Chief Executive, Marge Anderson has committed her efforts to ensuring that the interests of the Mille Lacs Band are protected on the national front, and has proven effective, outstanding leadership on national issues, and;

WHEREAS, the Tribal Executive Committee of the Minnesota Chippewa Tribe (MCT) has endorsed Chief Executive, Marge Anderson for the position of NCAI Minneapolis Area Vice President.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe Indians hereby strongly supports and endorses Chief Executive Anderson in her candidacy for the position of NCAI Area Vice President for the Minneapolis Area Office.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 24 th day of November, 1993 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
