## **RESOLUTION 06-02-135-94**

A RESOLUTION REQUESTING THAT THE BUREAU OF INDIAN AFFAIRS PLACE LAND IN TRUST FOR THE MILLE LACS BAND OF OJIBWE.

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Oilbwe, and:

WHEREAS, the Mille Lacs Band of Ojibwe have acquired land within exterior boundaries of the Mille Lacs Reservation for agriculture and housing, and;

WHEREAS, the Mille Lacs Band of Ojibwe wishes to put these lands transferred to the United States in trust for the Mille Lacs Band of Ojibwe.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band of Ojibwe is hereby requesting the Bureau of Indian Affairs to accept the following land to be put in trust:

Parcel -10 real property in Mille Lacs County, Minnesota, described as follows:

The Southwest one-quarter (SW1/4) of Southwest One-quarter (SW1/4) and the South One-half (S1/2) of Southeast One-quarter (SE1/4) of Southwest One-quarter (SE1/4) of Section 7, Township 43, Range 27 and the following described tract in Government Lot 3, in Section 18, Township 43, Range 27, to-wit: Beginning at the northeast corner of Lot 8 of Plat of Whitefish (which is also known as Lot 8 of Block a of Plat of Whitefish) according to the pleat thereof; thence East along the north boundary line of said Lot 8, extended (which said line is also a section line) for a distance of 400 feet to the point of beginning; thence South and parallel with east boundary line of said Lot 8, extended, to the Water's edge of Whitefish Lake; thence in an easterly direction along the water's edge of said Whitefish Lake to a point where the East Boundary line of said Government Lot 3 intersects with the water's edge of said Whitefish Lake; thence North along the east boundary line of said Government Lot 3 to the Northeast corner of said Government Lot 3, thence along the North boundary line of said Government Lot 3 (which is also a section line) to the point of beginning.

Parcel -8 real property in Mille Lacs County, Minnesota, described as follows:

The East Half (E1/2) of government Lot One (1), also known as the East Half of the Northeast Quarter of the Northeast Quarter (E1/2 of NE 1/4 of NE1/4), of Section Two (2), Township Forty-two (42), Range Twenty-five (25). AND The South Eight (8) acres, also described as the South Sixteen (16) rods of the Southwest Quarter of the Southwest Quarter (SW 1/4 SW 1/4) of Section 36, Township 43, Range 25. AND The Northwest Quarter of the Northwest Quarter (NW 1/4 NW 1/4) of Section 1, Township 42 Range 25, lying North of the Sault Ste. Marie Railroad right of way, AND The Northeast Quarter of the Northwest Quarter (NE 1/4 NW 1/4) also known as Government Lot 3, Section 1, Township 42, Range 25. Mille Lacs County Minnesota.

Parcel -11 real property in Crow Wing County, Minnesota described as follows:

The East half of the Southeast Quarter (E1/2 SE 1/4), Section tweleve (12), Township Forty-Three (43), Range Twenty-eight (28). Crow Wing County State of Minnesota Containing eighty ares (80), more or less.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 23rd day of August, 1994 at Vineland, Minnesota by a vote of \_3\_\_FOR, \_0\_ AGAINST, \_0\_\_SILENT.
