RESOLUTION 05-04-10-94

A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]

WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;

WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;

WHEREAS, tribal land leases are needed from the Band Assembly for the purpose of repayment of home loans-Minnesota Chippewa Tribe Home Loan Program in case of a default, and;

WHEREAS, said land is described as follows: Commencing at the SE corner of Lot C, thence East 1 degree 51 minutes 57 seconds North for a distance of 200 ft., thence East along the Southerly line of County State aid Highway 35 for a distance of 100 ft., thence South a distance of 200 ft., thence West a distance of 100 ft. to point of beginning, all in Gov. Lot 2, Section 17, Twp. 43N, R27W, Mille Lacs County, State of Mn., in Maple Hills Addition, Mille Lacs Indian Reservation, known as Parcel D.


WHEREAS, the lease will have to be for a period of 25 years plus 25 years effective November 2nd, 1993 for the purpose of financing this home.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective November 2, 1993.

BE IT FURTHER & FINALLY RESOLVED, that lessee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, or if the lessee defaults on their home mortgage, this lease will then revert back to the Mille Lacs Band of Chippewa Indians.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 2nd day of Nov., 1993 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of Assembly to be affixed to this resolution and forwarded to the Chief Executive for concurrence.
