## RESOLUTION 06-01-88-94

A RESOLUTION IN SUPPORT OF THE CENTER OF AMERICAN AND MINORITY HEALTH'S RE-APPLICATION PROPOSAL REQUESTING AN ADDITIONAL THREE YEARS FUNDING, SEPTEMBER 1995 -- AUGUST 1998, FOR THE UNIVERSITY OF MINNESOTA INDIANS INTO MEDICINE PROGRAM FROM THE INDIAN HEALTH SERVICE (IHS).

- WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, the Center of American Indian and Minority Health, University of Minnesota, Duluth, School of Medicine has a successful program titled: University of Minnesota Indians into Medicine (UM INMED), and
- WHEREAS, the University of Minnesota Indians into Medicine (UM INMED) program has been in operation since September 1992, and provides program activities that promote, strengthen, and enhance American Indian students' interest and potential to pursue a career in medicine or health, at the K-12, college, and professional student levels, and
- WHEREAS, the University of Minnesota Indians into Medicine program offers its activities to all 30 tribes in a four state target area which includes: Wisconsin, Michigan, Iowa, and Minnesota.
- NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Ojibwe Indians does support the Center of American and Minority Health's reapplication proposal requesting an additional three years funding, September 1995 -- August 1998, for the University of Minnesota Indians into Medicine program from the Indian Health Service (IHS), and
- BE IT FURTHER RESOLVED, that the Mille Lacs Band of Ojibwe Indians does support the Center of American Indian and Minority Health's efforts to stabilize the UM Indians into Medicine program continuance and permanence by recommending the UM INMED program become a regular line item in the Indian Health Service' annual budget.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 15th day of April, 1994, at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
