**RESOLUTION 06-03-64-95**

A RESOLUTION TO SUPPORT AND AUTHORIZE THE USE OF FORCE ACCOUNT CONSTRUCTION BY THE MILLE LACS HOUSING AUTHORITY UNDER THE GRANT REQUEST FOR A NEW 40 -UNIT HOUSING DEVELOPMENT PROJECT (LOW RENT).

- WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, the number one priority of the Mille Lacs Band is to improve the overall quality of life for the people of the Mille Lacs Reservation; and,
- WHEREAS, the Mille Lacs Housing Authority is in a position to organize and manage a force account construction project and thereby train and employ increased numbers of Indian residents.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Chippewa Indians does support and authorize the use of Force Account Construction by the Mille Lacs Housing Authority under the Grant Request for a new 40-unit Housing Development Project (Low Rent).

BE IT FURTHER RESOLVED, that the Mille Lacs Band Assembly does hereby authorize the Mille Lacs Housing Authority to enter into an agreement with the Department of Housing and Urban Development to use the force account method in the construction for a 40-unit Housing Project (Low Rent).

BE IT FURTHER RESOLVED, that the Mille Lacs Band does hereby authorize the Chief Executive to state in writing that the Mille Lacs Band of Chippewa Indians would assume responsibility for any project cost in excess of the HUD-approved development budget, including contingencies, for the 40-unit proposed Housing Project, except in the case where HUD reduces or eliminates funding for the project.


BE IT FURTHER RESOLVED, that the Mille Lacs Band Assembly does hereby authorize the Chief Executive and Secretary-Treasurer to enter into a letter of credit with a qualified lending institution with FDIC insurance in lieu of the HUD-required bond for the 40-unit Housing Project, and to sign any documents necessary to implement the letter of credit, and;

BE IT FURTHER AND FINALLY RESOLVED, if the request for funds is granted that the Mille Lacs Band Assembly does hereby authorize the Chief Executive and Secretary-Treasurer to enter into a letter of credit with a qualified lending institution.


