## **RESOLUTION 06-04-139-95**

A RESOLUTION IN SUPPORT OF THE PROPOSED OUTSTANDING NATIONAL RESOURCE WATER (ONRW) DESIGNATION FOR LAKE SUPERIOR

WHEREAS: the Mille Lacs Reservation Band Assembly is the duly elected governing

body of the Mille Lacs Band of Ojibwe Indians, a Federally recognized Indian

Tribe; and,

WHEREAS: the great Lake Superior is the largest fresh water lake on the North American

Continent and has been culturally and spiritually significant to the Ojibwe

nations of the United States and Canada since time immemorial, and,

WHEREAS: Lake Superior provides livelihoods for numerous Tribal commercial fishermen

and subsistence fishing for many Red Cliff Tribal member; and,

WHEREAS: Lake Superior is the largest fresh water lake in the world, is the source of

drinking water for many communities, has a recognized sport fishing industry.

and is the nucleus of tourism industries across the basin; and

WHEREAS: The International Joint Commission has identified and summarized scientific

evidence to reach the conclusion that persistent bioaccumulative toxic substances are a serious threat to the health of the Great Lakes Ecosystem,

including Lake Superior; and.

WHEREAS: Ojibwe Indians agree with the findings of the International Joint Commission;

and,

WHEREAS: The unique ecological values of Lake Superior has also been recognized by the

United States, Canada, Wisconsin, Michigan, Minnesota and Ontario when nearly four years ago they agreed to the Binational Program to Restore and protect the Lake Superior; and efforts must be increased to protect these waters

from further degradation for all generations to follow

WHEREAS: The governments that are party to the Binational Program have failed to

implement the protective provisions of the Binational Program to Restore and

protect the lake Superior Basin; and

WHEREAS: The best existing federal protection for Lake Superior is a designation of

Outstanding National Resource Waters (ONRW) which prevents new or

increased loadings of persistent bioaccumulative toxins; and

NOW, THEREFORE, BE IT RESOLVED: that the Mille Lacs Band of Ojibwe Indians hereby

supports a federal Outstanding National Resource Water Designation for Lake

Superior.

BE IT FURTHER RESOLVED: That the Tribal Council of the Mille Lacs Band of Ojibwe Indians hereby designates the Waters of Lake Superior as Sacred and calls upon the United State to afford the highest level of protection as part of the fulfillment of their Trust Responsibility to the Tribes of Lake Superior by protecting the waters resources of the Lake that are our Treaty resources and that our cultural identity depends upon.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17th. day of August, 1995 at East Lake Minnesota by a vote of <u>2</u> FOR, <u>0</u> AGAINST, <u>0</u> SILENT.
