RESOLUTION 06-03-43-95.

A RESOLUTION REQUESTING THAT THE BUREAU OF INDIAN AFFAIRS PLACE LAND IN TRUST FOR THE MILLE LACS BAND OF OJIBWE.

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, and;
- WHEREAS, the Mille Lacs Band of Ojibwe have acquired land within exterior boundaries of the Mille Lacs Reservation for agriculture and housing, and;
- WHEREAS, the Mille Lacs Band of Ojibwe wishes to put these lands transferred to the United States in trust for the Mille Lacs Band of Ojibwe.


NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band of Ojibwe is hereby requesting the Bureau of Indian Affairs to accept the following land to be put in trust:

-real property in Mille Lacs County, Minnesota, known as Parcel 13, described as follows:

The East 165 feet of the South Half of Northwest Quarter of Northwest Quarter of Southwest Quarter (S 1/4 of NW 1/4 of NW 1/4 of SW 1/4), Section One (1), Township forty-two (42), Range Twenty-five (25), containing one and one-quarter (1.25) acres, more or less. Together with an easement for public travel along with others over the North Sixteen and one-half (16.5) feet of the said South half of Northwest Quarter of Northwest Quarter of Southwest Quarter (S1/4 of NW 1/4 of NW 1/4 of SW 1/4) of Section one (1), Township forth-two (42), Range Twenty-five (25), and an easement for travel along with others over the South Sixteen and one-half (16.5) feet of the North half of the Northwest Quarter of the Northwest Quarter of the Southwest Quarter (N1/2 of NW 1/4 of NW 1/4 of SW 1/4), Section one (1), Township forty-two (42), Range Twenty-five (25).

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 18th day of January, 1995 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
