RESOLUTION 06-04-127-95 A

AMENDMENT TO RESOLUTION 06-04-127-95 GRANTING RIGHT-OF-WAY ACROSS LANDS UNDER THE JURISDICTION OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE INDIANS TO MILLE LACS ELECTRIC COOPERATIVE FOR THE PURPOSE OF INSTALLING ELECTRIC STREET LIGHTS.

- WHEREAS, Mille Lacs Electric Cooperative is desirous of obtaining a twenty five (25) year right-of-way for use on the premises in connection with said purpose beginning on 11th day of July, 1995, and;
- WHEREAS, Band Statute 1094-MLC-47, designates rules and regulations governing the issuance of right-of-way across lands under the jurisdiction of the Band, and;
- WHEREAS, pursuant to his statutory authority, the Commissioner of Natural Resources has reviewed the request of the Mille Lacs Electric Cooperative and does hereby recommend that the Chief Executive approve said right-of-way request; and,
- WHEREAS, Mille Lacs Electric Cooperative will not be able to transfer this right of way without written approval of the Mille Lacs Band.
- NOW, THEREFORE, BE IT RESOLVED, that the request for a right-of-way across lands necessary for construction and repair of electric lights and lines herein described as:

NE 1/4 of SW 1/4 of Section 28, Township 43, Range 27 SW 1/4 of the NE 1/4 of Section 28, Township 43, Range 27 SE 1/4 of the NE 1/4 of Section 28, Township 43, Range 27 NE 1/4 of the SE 1/4 of Section 28, Township 43, Range 27 NW 1/4 of the NE 1/4 of Section 28, Township 43, Range 27 SW 1/4 of the SW 1/4 of Section 21, Township 43, Range 27 NE 1/4 of the NE 1/4 of Section 29, Township 43, Range 27 SW 1/4 of the SW 1/4 of Section 16, Township 43, Range 27
