RESOLUTION 06-04-142-95

A RESOLUTION GRANTING NEW LAND LEASE FOR [REDACTED]

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe Indians, and;
- WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;
- WHEREAS, a tribal land lease is needed for the purpose of homesites on tribal lands for the Mille Lacs Reservation, and;
- WHEREAS, the lease will be for a period of 25 years plus 25 years renewal effective August 29th, 1995 for the purpose of a homesite, and;
- WHEREAS, said land is described as follows: That part of the NE 1/4 of SE 1/4, Section 17, North Kathio Township 43N, Range 27 W, Lots 1 and 2, Block 1, Maple Bank, known as Shaw Bosh Kung Point, and Lots 1 & 2, Block 1, extended 50ft. into road known as Ge-Ke-Beig Drive, according to plat map of Shaw-Bosh-Kung-point, Mille Lacs Reservation, Mille Lacs County, State of Minnesota.


NOW THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective August 29th, 1995.

BE IT FURTHER RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.

BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the leasee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.


