RESOLUTION 06-04-135-95

A RESOLUTION IN CONCURRENCE WITH CHANGES TO PUBLIC LAW 102-485, THE FAMILY SUPPORT ACT WHICH WILL INCLUDE OTHER TRIBAL AFDC RECIPIENTS RESIDING IN ITS DESIGNATED SERVICE AREAS.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Reservation, and;
- WHEREAS, effective October 1, 1995, Public Law 102-485, the Family Support Act has been amended by Public Law 103-432, the Social Security Act Amendments of 1994, that changes the service population provision guidelines for Tribal Jobs programs to include other Tribal AFDC recipients not currently being counted and served by existing Tribal JOBS Programs; and;
- WHEREAS, existing Tribal JOBS Programs have been directed by the Family Support Administration to determine services population provision for other Indian AFDC recipients currently being counted and served by county social service agencies and who reside in overlapping service areas to Tribal JOBS Programs; and,
- WHEREAS, the Family Support Administration has identified four factors of the agreement which include: a) the percentage of AFDC recipients each grantee is currently serving, b) the availability of mandatory and optional components, c) the demonstrated capacity of serving recipients d) the coordination and integration of JOBS with other programs; and,
- WHEREAS, based on the above four factors the Tribal JOBS Programs of Mille Lacs Band Assembly has reached an agreement regarding service provision to eligible non-Minnesota Chippewa AFDC recipients who reside with our designated service areas; and,
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band JOBS Program will continue to provide service to their existing service group which include all Mille Lacs members who are AFDC recipients within our designated service areas; and,
- BE IT FURTHER RESOLVED, that the JOBS Programs in addition to its current recipients will also serve all eligible Red Lake AFDC recipients and all other non-Minnesota Chippewa Tribal AFDC recipients residing in its designated service area; and,
- BE IT FURTHER AND FINALLY RESOLVED, that the Mille Lacs Band Assembly does hereby approve and submit the designated service providers agreement to the Family Support Administration on behalf of the JOBS Program of the Mille Lacs Band of Ojibwe Indians.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 24th day of July, 1995 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
