RESOLUTION 06-03-45-95

A RESOLUTION PERTAINING TO THE TERMINATION OF LAND LEASE AGREEMENT FOR [REDACTED]

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe Indians, and;
- WHEREAS, the Mille Lacs Band Assembly is responsible for all land lease agreements, etc, and;
- WHEREAS, [REDACTED] has abandoned her homesite located at the following land description;
- WHEREAS, said land is described as follows: Part of the Northwest Quarter of the Northwest Quarter and part of Indian Allotment 11 all in Section 28, Township 43, Range 27, Mille Lacs County, Minnesota, in accordance with the supplemental plat of Sections 27, 28, and 29, Township 43, Range 27, West of the Fourth Principal Meridian, Minnesota, as certified by Frank M. Johnson, Supervisor of Surveys of the General Land office on December 11, 1924, and filed of record in the office of the Secretary of State of Minnesota, described as commencing at the northwest corner of said Section 28, thence east along the north line of said Northwest Quarter a distance of 329.44 feet more or less to the northwest corner of said Indian Allotment 11; thence southerly along the west line of Indian Allotment 11 a distance of 620.44 feet more of less, to it's intersection with the north line of a road known as West Side Road, the point of beginning of the tract to be described; thence northerly along said west line of Indian Allotment 11 a distance of 200.00 feet; thence easterly, parallel with said north line of said road a distance of 100.00 feet; thence southerly, parallel with said west line of Indian Allotment 11 a distance of 200.00 feet to the north line of road; thence Westerly along said north line of said road to the point of beginning.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Ojibwe Indians terminated this land lease effective January 24, 1995


WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 24th day of January, 1995 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
