RESOLUTION 06-03-81-95

A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]

- WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;
- WHEREAS, a tribal land lease is needed for the purpose of homesites on tribal lands for the Mille Lacs Reservation, and;
- WHEREAS, the lease will be for a period of 25 years plus 25 years effective April 11, 1995 for the purpose of a homesite, and;
- WHEREAS, said land is described as follows: That part of the Northeast Quarter of the Southwest Quarter, Section 18, Township 43 North, Range 27 West, of the Forth Principal Meridian, in Mille Lacs County, Minnesota, described as following, Commencing at the Southeast corner of said Northeast Quarter of the Southwest Quarter: thence North 00 degrees 53 minutes 33 seconds West 33.00 feet along the east line of said Northeast Quarter of the Southwest Quarter;; thence North 89 degrees 58 minutes 27 seconds West 200.00 feet to the point of beginning; thence North 00 degrees 53 minutes 33 seconds West 200.00 feet; thence North 89 degrees 58 minutes 27 seconds West 100.00 feet; thence South 00 degrees 53 minutes 33 seconds East 200.00 feet; thence South 89 degrees 58.27 seconds East 100.00 to the point of beginning.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective April 11th, 1995.

BE IT FURTHER RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.

BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the leasee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.


WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 11th day of April, 1995 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST,     SILENT.
