RESOLUTION 06-03-87-95

A RESOLUTION REQUESTING THAT THE BUREAU OF INDIAN AFFAIRS PLACE LAND IN TRUST FOR THE MILLE LACS BAND OF OJIBWE.

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, and;

WHEREAS, the Mille Lacs Band of Ojibwe have acquired land within exterior boundaries of the Mille Lacs Reservation for number of purposes, such hunting, fishing, and gathering, area for recreational development and cemetery use,

WHEREAS, the Mille Lacs Band of Ojibwe wishes to put this land transferred to the United States in trust for the Mille Lacs Band of Ojibwe.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band of Ojibwe is hereby requesting the Bureau of Indian Affairs to accept the following land to be put in trust:


