RESOLUTION 06-02+1695

A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]

WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;

WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;

WHEREAS, tribal land leases are needed from the Band Assembly for the purpose of repayment of home loans-Minnesota Chippewa Tribe Home Loan Program in case of a default, and;

WHEREAS, said land is described as follows: That part of the NE 1/4 of Section 23, Twp. 41, Range 20, Pine County, MN.

Commencing at the NE 1/4 corner of said NE 1/4, thence South 01 degree 36 Minutes. 1 second East, assumed bearing along the East line of said NE 1/4 33:00 ft. to the point of beginning of the parcel to be described, thence continuing South 88 degrees 23 minutes 59 seconds West 238 ft., thence South 0 degrees 36 minutes 01 second East parallel with said East line of the NE 1/4 190 ft. thence north 88 degrees 23 minutes 59 seconds East 236 ft, thence North 01 degrees 36 minutes 01 second West parallel with said East line of the NE 1/4 and along the right-of-way of County Road 20 183.1 ft. to the point of beginning.


WHEREAS, the lease will have to be for a period of 25 years plus 25 years effective November 9th, 1994 for the purpose of financing this home.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective November 9th, 1994.

BE IT FURTHER & FINALLY RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, or if the leasee defaults on their home mortgage, this lease will then revert back to the Minnesota Chippewa Tribe.


WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 9th day of November, 1994 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of Assembly to be affixed to this resolution and forwarded to the Chief Executive for concurrence.
