## RESOLUTION 06-02-07-95

A RESOLUTION IN SUPPORT OF THE SUBMISSION OF PROPOSAL TO THE STATE OF MINNESOTA COMMUNITY CRIME AND DRUG PREVENTION AND HIGH-RISK YOUTH VIOLENCE PREVENTION ACTIVITIES FUNDING.

- WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, the number one priority of the Mille Lacs Band is to improve the overall quality of life for the people of the Mille Lacs Reservation, and;
- WHEREAS, the Mille Lacs Band Assembly respectfully requests funding assistance from the State of Minnesota Department of Public Safety, Office of Drug Policy and the Department of Education, Office of Community Collaboration for Community Crime and Drug Prevention and High-Risk Youth Violence Prevention Activities and:
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Chippewa Indians does hereby approve and authorize the acceptance of funds from the State of Minnesota Department of Public Safety, Office of Drug Policy and the Department of Education, Office of Community collaboration.
- BE IT FURTHER RESOLVED, that the Commissioner of Administration and the Commissioner of Human Services are authorized to sign on behalf of the Non Removable Mille Lacs Band of Chippewa Indians.
- BE IT FURTHER & FINALLY RESOLVED, that in the absence of the Commissioner of Administration ration, it is hereby authorized that the Assistant Commissioner of Administration be authorized to sign on behalf of the Commissioner of Administration.
- IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
