RESOLUTION 06-03-96-95

A CONTINUING RESOLUTION FOR THE JUDICIAL ACCOUNT STRUCTURE OF THE MILLE LACS BAND OF OJIBWE INDIANS FOR THE MONTH OF MAY, 1995, WHICH IS IN LIEU OF A FORMAL APPROPRIATION STATUTE.


- WHEREAS, ordinance 02-82, Sub. Sec. 8, mandates the appropriation of all Band revenue prior to the commencement of a new fiscal year; and,
- WHEREAS, the Band Assembly did adopt formal appropriations of programmatic and other governmental accounts for FY 1995, with the exception of the Judicial account; and,
- WHEREAS, the Band Statute 1143-MLC-4 is presently undergoing statute revision, which may or may not change the personnel structure, depending on Band member sentiment, and,
- WHEREAS, revisions to Band Statutes, chapters 1, 2, 3, and 4 require public hearing before any formal action by the Band Assembly, and will take place during the month of April, 1995, and,
- WHEREAS, the Band Assembly of the Mille Lacs Band of Ojibwe Indians continues to review all necessary financial information in order to ensure the financial integrity of the Band.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe Indians hereby authorizes the continuance of the Judicial Branch account for a period of thirty one (31) days to expire on midnight, May 31, 1995, said expenditures shall not exceed the amount listed:

Judicial Branch            14,975.00

Should Judicial Branch fail to have sufficient cash fund balance to continue operations, immediate program shut-down shall occur.

IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
