## RESOLUTION 06-04-148-95

A RESOLUTION GRANTING A LAND LEASE TO THE MILLE LACS RESERVATION HOUSING AUTHORITY.

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe Indians, and;

WHEREAS, the Mille Lacs Indian Housing Authority wishes the lease of lots on the Mille Lacs Reservation for the purpose of homesites, and;

WHEREAS, tribal land lease are needed from the Band Assembly for the purpose of financing and building of homes, and:

- WHEREAS, the Mille Lacs Indian Housing Authority is authorized to sublease these sites, and;
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the leases to be issued to the Mille Lacs Indian Housing Authority for a period of 25 years plus 25 years renewal effective September 8th, 1995.
- BE IT FURTHER & FINALLY RESOLVED, that lease will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, this lease will then revert back to the Mille Lacs Band of Ojibwe Indians.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 8th day of September, 1995 at Vineland, Minnesota by a vote of \_3\_\_ FOR, \_\_0\_ AGAINST, \_\_0\_ SILENT.
