**RESOLUTION 06-04-03-96**

A RESOLUTION IN SUPPORT OF THE SUBMISSION OF A PROPOSAL FOR A MODEL COMMUNITY SERVICE CENTER PROJECT FOR INDIAN ELDERS FROM STATE OF MINNESOTA, DEPARTMENT OF HUMAN SERVICES

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe Indians; and,

WHEREAS, the number one priority of the Mille Lacs Band Assembly is to improve the overall quality of life for the people of the Mille Lacs Reservation; and,

WHEREAS, the Mille Lacs Ojibwe Elderly population, which there are 172 living on Mille Lacs Reservation, is the least vocal, and most vulnerable to the changes in their environment, be it physical, social or spiritual; and,

WHEREAS, The Mille Lacs Ojibwe Elderly have organized Elder Councils on all three respective Districts to have a voice in determining their issues, needs and solutions; and,

WHEREAS, the Elder Councils has been presented with the proposal for the Model Community Service Center from the State of Minnesota Department of Human Services and was agreed upon by those in attendance to submit the application for funding.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby support the application for the Model Community Service Center to the State of Minnesota Department of Human Services


.BE IT FURTHER & FINALLY RESOLVED, that the Commissioner of Administration and the Commissioner of Health and Human Services of the Mille Lacs Band of Ojibwe Indians are authorized to sign off on all contracts on behalf of the Chief Executive.
