RESOLUTION 07-01-46-96

A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe Indians, and;

WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homestead, and;

WHEREAS, a tribal land lease is needed for the purpose of homesteads on tribal lands for the Mille Lacs Reservation, and;

WHEREAS, the lease will be for a period of 25 years plus 25 years renewal effective February 22, 1996 for the purpose of a homestead, and;

WHEREAS, said land is described as follows:
Whence southeast corner Lot 33, also northeast corner Lot 40, bears north 100 feet of the northeast corner Lot 34, also southeast corner Lot 40, the point of beginning, thence south 100 feet to southeast corner Lot 34, thence west 200 feet to southwest corner Lot 34, thence north 100 feet to northwest corner Lot 34, also southeast corner Lot 40, thence east 200 feet to northeast corner Lot 34, also southeast corner Lot 40 in the east one half of the southeast quarter of the southeast quarter Section 17, Township 43N, Range 27 W.

NOW THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective February 22, 1996.

BE IT FURTHER RESOLVED, that lessee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.

BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 22nd day of February, 1996 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
