**RESOLUTION 06-04-19-96**

**A RESOLUTION IN SUPPORT OF AN APPLICATIONS FOR FUNDING FROM THE MINNESOTA DEPARTMENT OF ECONOMIC SECURITY FOR THE ANISHINABE SENTENCE TO SERVE PLUS PROGRAM.**

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe Indians, a federally-recognized Indian Tribe; and,
- WHEREAS, the Mille Lacs Reservation Band Assembly is aware of the Youth Intervention Program, administered by the Minnesota Department of Economic Security; and,
- WHEREAS, the Mille Lacs Band of Ojibwe Indians is desirous of submitting a grant application with the intent on developing a project entitled Anishinabe Sentence-to-Serve Plus (STS+) to be implemented on the Mille Lacs Indian Reservation; and,
- WHEREAS, the Anishinabe Opportunities Industrialization Center (A.O.I.C.) of the Mille Lacs Indian Reservation shall be the implementing agency and that a 2:1 ratio in matching funds is hereby committed to by the Band.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby wholeheartedly support and endorse the application for funding the Anishinabe STS Plus Program; and,

BE IT FURTHER AND FINALLY RESOLVED, that Terry Anfinson, for the Anishinabe OIC, and James Genia Solicitor General for the Mille Lacs Band of Ojibwe Indians are hereby authorized to apply and execute such agreement as are necessary to implement the project on behalf of the Chief executive of the Mille Lacs Band of Ojibwe Indians.

IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
