RESOLUTION 07-01-111-96

A RESOLUTION TO APPROVE THE SIGNING OF ANNUAL FUNDING AGREEMENT WITH THE BUREAU OF INDIAN AFFAIRS.

- WHEREAS, the Mille Lacs Reservation Band Assembly is a duly elected governing body of the Mille Lacs Band of Ojibwe and fully authorized to act on behalf of its members; and.
- WHEREAS, the Band Assembly is empowered by 3MLBSA sub section 2 (a) and (d), to adopt Resolutions which promote the general welfare of the people; and,
- WHEREAS, the Band has determined that entering into a Self-Governance Compact and Annual Funding Agreement with the Department of the Interior pursuant to Title IV of P. L 93-638, as amended, supports and enhances the Bands sovereignty; and,
- WHEREAS, negotiations have resulted in a Fiscal Year 1997 annual funding agreement between the Band and the Department of the Interior which provides a share of BIA funds for the Mille Lacs Band; and,
- WHEREAS, successful Self-Governance for the Mille Lacs Band is of the most immediate importance to the perpetuation of the Mille Lacs Band of Ojibwe.
- NOW THEREFORE BE IT RESOLVED, the Fiscal Year 1997 annual funding agreement with the Bureau of Indian Affairs is hereby approved; and,
- BE IT FURTHER RESOLVED, that the Chief Executive, Speaker of the Assembly, the Commissioner of Administration and the Self-Governance Coordinator are authorized to execute all necessary documents on behalf of the Band; and,
- BE IT FURTHER AND FINALLY RESOLVED, that the Executive Branch of the Mille Lacs Band is authorized to continue to strive for complete Self-Governance and to take whatever lawful actions which the Chief Executive deems necessary which will further the quest for Self-Governance.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 26th day of June, 1996 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly have caused the hand signature of the Speaker of Assembly to be set to this resolution and forwarded to the Chief Executive for concurrence.
