A RESOLUTION GRANTING A LAND LEASE TO

WHEREAS,	the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe Indians, and;
WHEREAS,	wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;

- WHEREAS, a tribal land lease is needed for the purpose of homesites on tribal lands for the Mille Lacs Reservation, and;
- WHEREAS, the lease will be for a period of 25 years plus 25 years renewal effective March 1, 1996 for the purpose of a homesite, and;
- whereas, said land is described as follows: That part of the West Half of the Southwest Quarter of Section 18, Township 43, Range 27, Mille Lacs County, Minnesota, described as follows: Commencing at the northeast corner of said West Half of Southwest ?Quarter of the Southeast Quarter of said Section 18; thence North 89 degrees 45 minutes 18 seconds West, assumed bearing, 162.27 feel along the north line of said West Half of the Southwest Quarter of the Southeast Quarter to the point of beginning g of the tract of land to be described; thence South 00 53 minutes 15 seconds East 275.05 feet; thence North 89 degrees 45 minutes 18 seconds West 162.02 feet to the west line of East Half of the Northwest Quarter of the Southwest Quarter of the Southwest / Quarter of said Section 18; thence

the Southwest Quarter of the Southeast /quarter of said Section 18; thence North 00 degrees 56 minutes 24 seconds West 275.05 feet along said west line to the northwest corner of said East Half of the Northwest Quarter of the Southwest Quarter of the Southeast Quarter, thence South 89 degrees 45 minutes 18 seconds East 162.27 feet along the north line of said West Half of the Southwest Quarter of the Southeast Quarter to the point of beginning. Subject to a road easement for township road and subject to a road easement over the east 15.00 feet thereof

- NOW THEREFORE, BE IT RESOLVED. that the Mille Lacs Band Assembly hereby approves a lease to be issued to be i
- BE IT FURTHER RESOLVED, that lease will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.
- BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the leasee abandon or vacate the above described property for more than thirty (30) days without the prior approval of the Band Assembly.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 1st day of March, 1996 at Lake Lena, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
