### RESOLUTION 07-02-141-96

#### A RESOLUTION GRANTING A LAND LEASE TO DEPARTMENT OF NATURAL RESOURCES.

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a Federally-recognized Indian Tribe, and;
- WHEREAS, the Department of Natural Resources of the Mille Lacs Band of Ojibwe wishes the lease of a lot on the Mille Lacs Reservation for the purpose of recreational park, and;
- WHEREAS, a tribal land lease is needed for the purpose of a recreational park on tribal lands for the Mille Lacs Reservation, and;
- WHEREAS, the lease will be for a period of 5 years plus 5 years renewal effective August 27, 1996 for the purpose of a recreational park, and;
- WHEREAS, said land is described as follows: Beginning at the land survey marker stake on Highway 169 in the Northwest corner of Section 28, thence East 1,285.55 feet, thence South 300 feet, thence West 100 feet, thence South 100 feet, thence West 990 feet, thence North 266 feet, thence West 195.55 feet, thence North 158.47 feet to the point of beginning and there terminating. All in Kathio Twp 43N, R27W, Section 28, Vineland Hills plat on the Mille Lacs Reservation, State of Minnesota, County of Mille Lacs.

NOW THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to Department of Natural Resources of the Mille Lacs Band of Ojibwe for a period of 5 years plus 5 years renewal effective August 27, 1996.

BE IT FURTHER RESOLVED, that lessee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.

BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 27th day of August, 1996 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
