**RESOLUTION 07-01-104-96**

**A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]**

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a Federally-recognized Indian Tribe, and;

WHEREAS, tribal land leases are required for the purposes of a homesite, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs Reservation, and;

WHEREAS, [REDACTED] respectfully requests the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite and has applied to the Minnesota Chippewa Tribe Home Loan Program, for financing, and;

WHEREAS, the lease will have to be for a period of 25 years plus 25 years effective May 21st, 1996, for the purpose of financing this home; and,

WHEREAS, said land is described as follows:


Tract D- The west 200.00 feet of the East 782.57 feet of the South 474.97 feet of the East half of the Southeast Quarter of Section 12, Twp.43, Range 28, Crow Wing County, MN. Subject to right of way for County Road 2 over the Southerly 50 feet thereof.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective May 21st, 1996.

BE IT FURTHER & FINALLY RESOLVED, that lessee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, or if the lessee defaults on their home mortgage, this lease will then be assigned to the Minnesota Chippewa Tribe Home Loan Program.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 21st day of May, 1996 at Vineland, Minnesota by a vote of   3   FOR,   0   AGAINST,   0   SILENT.
