RESOLUTION 06-04-28-96

**A RESOLUTION REQUESTING THE BUREAU OF INDIAN AFFAIRS-  
MINNEAPOLIS AREA OFFICE-TO ALLOW FOR THE THE REDEFINITION OF  
THE SERVICE DELIVERY AREA FOR THE NAY AH SHING SCHOOL OF THE  
MILLE LACS RESERVATION.**

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band Ojibwe Indians, a federally-recognized Indian Tribe, and;
- WHEREAS, the number one priority of the Mille Lacs Reservation Band Assembly is to provide for the Education and Welfare of the eligible and enrolled members living on or near trust lands of the Mille Lacs Band of Ojibwe; and,
- WHEREAS, current information within the Bureau of Indian Affairs Minneapolis Area Office does not accurately reflect the Service delivery area, the reservation area and does not include District II and III, therefore service and jurisdiction to these areas is not currently allowed; and,
- WHEREAS, enrolled members in District II and III have requested participation in the Nay ah Shing Schools in District I however funds are not allocated for their inclusion.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Reservation Band Assembly on behalf of the Nay ah Shing Consolidated School Board do hereby formally request that the redefinition of the service delivery area for the Mille Lacs Reservation for purpose of serving the Educational need of enrolled Mille Lacs Band members.

BE IT FURTHER RESOLVED, that the redefinition of the service delivery area be recognized as a 33 mile radius around each District Community Center, and may include eligible enrolled Band members who wish to participate in the Educational Program of Nay Ah Shing Schools who may be outside the perimeter.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 15th day of December, 1995 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of Assembly to be affixed to this resolution and forwarded to the Chief Executive for concurrence.
