**RESOLUTION 07-02-122-96**

**A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]**

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a Federally-recognized Indian Tribe, and;
- WHEREAS, tribal land leases are required for the purposes of a homesite, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs Reservation, and;
- WHEREAS, the lease will be for a period of 25 years plus 25 years renewal effective July 16th, 1996 for the purpose of a homesite, and;
- WHEREAS, said land is described as follows:

That part of the S 1/2 of SE 1/4 of SW 1/4, Section 7, Twp 43N, R 27W, Kathio Twp. North, Mille Lacs Co. State of MN. Beginning at the section line post marker on Hwy 2, thence W 400ft, along Hwy 2 on Whitefish Lake, the point of beginning, thence N. 250 feet, thence W 150 feet, thence S250 ft, thence E 150 ft, to point of beginning and there terminating.


NOW THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective July 16th, 1996.

BE IT FURTHER RESOLVED, that lessee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.


BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above described property for more than thirty (30) days without the prior approval of the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 16th day of July, 1996 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
