WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17th day of April, 1997 at Vineland, Minnesota by a vote of _2_FOR, _0_AGAINST, _0_SILENT.
