RESOLUTION 07-03-47-97

A RESOLUTION REQUESTING TO ADD THE FOLLOWING ROADS TO THE BIA ROADS INVENTORY.

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of

the Mille Lacs Band of Ojibwe; a Federally-recognized Indian Tribe; and.

WHEREAS, the Mille Lacs Band of Ojibwe have contracted under the provisions of the P.L.

93-638 to conduct transportation planning activities; and,

WHEREAS, some roads on the Mille Lacs Reservation have been identified which are not

currently on the BIA Road System but should be.

NOW THEREFORE BE IT RESOLVED, that we the Mille Lacs Reservation Band Assembly requests the following roads located on the Mille Lacs Reservation be added to the BIA Road system:

Route 0008 located in Section 3&4, T. 41N., R. 17W, having a total length of approximately 0.5 miles.

Route 0010 located in Section 21, T. 47N., R 23W, having a total length of approximately 0.2 miles.

Route 0011 located in Section 21, T. 47N., R 23W., having a total length of approximately 0.1 miles.

Route 0012 located in Section 21, T. 47N., R 23W., having a total length of approximately 0.1 miles.

Route 0013 located in Section 18, T. 43N., R 17W., having a total length of approximately 0.3 miles.

Route 0020 located in Section 28, T. 43N., R. 27W., having a total length of approximately 0.5 miles.

Route 0021 located in Section 28, T. 43N., R. 27W., having a total length of approximately 0.4 miles.

Route 0022 located in Section 28, T. 43., R. 27W., having a total length of approximately 0.3 miles.

Route 0023 located in Section 23, T. 41N., R. 20W., having a total length of approximately 0.4 miles.

Route 0024 located in Section 23, T.41N., R. 20W., havig a total length of approximately 0.4 miles.

Route 0026 located in Section 23, T.41N., R. 20W., having a total length of approximately 0.2 miles.

Route 0048 (Wadena Road) located in Section 28, T. 43 N., R. 27 W., having a total length of approximately 0.1 mile.

Route 0049 (Migizi Road) located in Section 28, T. 43., R. 27W., having a total length of approximately 0.8 miles.
