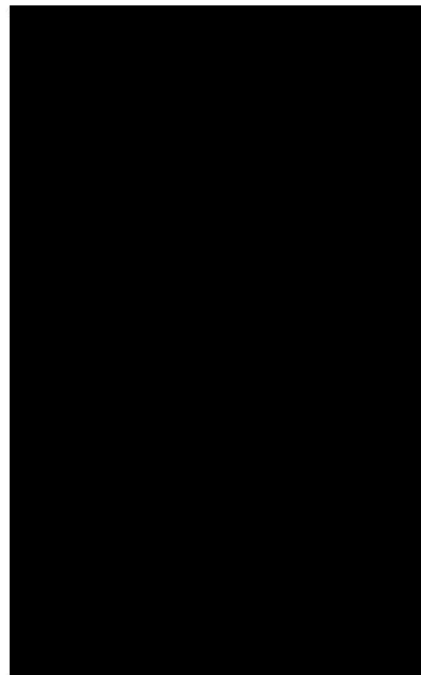
RESOLUTION 07-03-73-97
