**RESOLUTION 07-03-82-97**

**A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required for the purposes of a homesite, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs Reservation; and,
- WHEREAS, [REDACTED] respectfully requests a lease of a lot on the Mille Lacs Reservation for the purpose of a homesite; and,
- WHEREAS, the lease will have to be for a period of 25 years plus 25 years effective April 21<sup>st</sup> 1997, for the purpose of a homesite; and,
- WHEREAS, said land described as follows:

The East 396.50 feet of the N ½ of the following described tract D: that part of the NE ¼ of the SE ¼ of Section 12, Township 42, range 25, Mille Lacs County, Minnesota described as follows: Beginning at the NE corner of the NE ¼ of the SE ¼; thence South 651.75 feet; thence West 733.35 feet; thence North 651.75 feet thence East 733.35 feet to the point of beginning.

Subject to and together with an easement for ingress and egress purposes over, under and across the North 16.50 feet of the East 733.35 feet of the NE ¼ of the SE ¼ of Section 12, Township 42, Range 25

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective April 21<sup>st</sup> 1997.

BE IT FURTHER & FINALLY RESOLVED, that the leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, it will revert back to the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 21<sup>st</sup> day of April, 1997 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
