**RESOLUTION 07-0 4-115-97**

**A RESOLUTION TERMINATING A LAND LEASE TO [REDACTED]  
(DECEASED).**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required for the purposes of a homesite, agricultural and seasonal recreational residence, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs reservation, and;

WHEREAS, the Mille Lacs Band Assembly is responsible for all land lease agreements, etc, and;

WHEREAS, said land described as follows:

Beginning at the NW corner of the SW ¼ of the NE ¼ of Section 1, thence South 1,265 feet, thence East 45 feet to point of beginning, thence North 200 feet, thence East 100 feet, thence South 200 feet, thence West 100 feet to point of beginning in Township 42N, Range 25W.


NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly terminates this land lease to [REDACTED] deceased (resolution 05-03-96-93) effective August 12, 1997.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 12<sup>th</sup> day of August, 1997 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of Assembly to be affixed to this resolution and forwarded to the Chief Executive for Concurrence.
