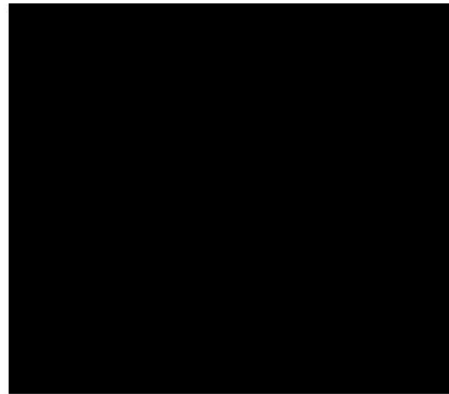
RESOLUTION 07-04-102-97




do meet the requirements for enrollment into the Minnesota Chippewa Tribe.
