**RESOLUTION 07-03-78-97**

**A RESOLUTION GRANTING A RELINQUISHMENT FROM THE MILLE LACS BAND, MILLE LACS RESERVATION TO THE FOND DU LAC RESERVATION.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following application for relinquishment from the Mille Lacs Band, Mille Lacs Reservation; and,


WHEREAS, [REDACTED] Dob: [REDACTED]

has signed a relinquishment form with the Minnesota Chippewa Tribe and relinquishes and surrenders any and all rights, title and interest that they may have in any undistributed property and assets of the Mille Lacs Band, Mille Lacs Reservation of the Minnesota Chippewa Tribe; and,

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does determine that these relinquishment is proper and that the interest of the individual has been considered and that this individual does meet the requirements for membership with the Fond du Lac Reservation and does approve the granting of the relinquishment for the above individual.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17<sup>TH</sup> day of April, 1997 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of Assembly to be affixed to this resolution and forwarded to the Chief Executive for Concurrence.
