**RESOLUTION 07-02-28-97**

**A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]**

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a Federally-recognized Indian Tribe, and;
- WHEREAS, tribal land leases are required for the purposes of a homesite, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs Reservation, and;
- WHEREAS, [REDACTED] respectfully requests the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite. and,
- WHEREAS, the lease will have to be for a period of 25 years plus 25 years effective November 27th, 1996, for the purpose of a homesite, and
- WHEREAS, said land is described as follows:


That part of Section 2, Township 42 Range 25 in Mille Lacs County; Beginning @ the Southeast corner of the Northwest Quarter of the Southeast Quarter of the Southeast Quarter; hence 320.00 feet west - hence 220.00 feet North - hence 320.00 feet east- hence 320.00 feet south to a point of beginning. Containing approximately 1.61 acres and subject to a right of way for Isle road over the east 50.00 feet there of.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective November 27th, 1996.


BE IT FURTHER & FINALLY RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, it will revert back to the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a Special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 27th day of November, 1996 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
