RESOLUTION 07-03-55-97

**A RESOLUTION IN SUPPORT OF THE NE-IA-SHINGS CLINICS' PARTICIPATION IN THE NORTHEAST MINNESOTA TRIBAL HEALTH PLANNING CONSORTIUM FOR THE PURPOSE OF MEETING COMMON HEALTH NEEDS AND THE CONSORTIUMS' SUBMISSION OF A TRIBAL MANAGEMENT GRANT TO THE INDIAN HEALTH SERVICE**

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe; a Federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly recognizes the changes occurring in the Indian Health Service and the regional, state and federal health care funding arenas; and,

WHEREAS, the Mille Lacs Band Assembly recognizes the need or inter-tribal health planning opportunities for mutual assistance and ways to become more influential in regional, state and federal health care policy initiatives; and,

WHEREAS, the goals of this program are to establish the Northeastern Minnesota Tribal Health Planning Consortium and submit a tribal Management Grant to assist in the consortium development and health planning for the consortium tribes.

NOW, THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby wholeheartedly supports and endorses participation in the Tribal Consortium, consisting of the Mille Lacs, Bois Forte, Grand Portage and Fond du Lac Tribes of Minnesota; and,

BE IT FURTHER AND FINALLY RESOLVED, that the Mille Lacs Band of Ojibwe supports and endorses the Fond du Lac Bands' Tribal Management Grant proposal to the Indian Health Service for the development of the Consortium and a cooperative health planning initiative. .

IN WITNESS WHEREOF, we, the Administration Policy Board hereunto cause to have set the signature of the Chief Executive to be affixed to this resolution and forward to the Band Assembly for concurrence.
