RESOLUTION 07-03-81-97

A RESOLUTION APPROVING THE ENROLLMENT INTO THE MILLE LACS BAND MILLE LACS RESERVATION, DUE TO AN INCREASE IN THEIR BLOOD QUANTUM.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applicants to be reconsider for enrollment; and,
WHEREAS, based on the blood quantum increases of Renne Jennifer Keggs and Gloria Jean Skinaway Nickaboine (07-03-80-97), their children:

do meet the requirements for enrollment into the Minnesota Chippewa Tribe; and,

WHEREAS, the changes should be made on the records of the Minnesota Chippewa Tribe.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above applications for enrollment and approves all rights provided for the Minnesota Chippewa Tribe enrollees.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17th day of April, 1997 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
