RESOLUTION 07-03-75-97

A RESOLUTION GRANTING TRANSFERS OF ENROLLMENT TO THE MILLE LACS BAND, MILLE LACS RESERVATION FROM THE WHITE EARTH RESERVATION OF THE MINNESOTA CHIPPEWA TRIBE.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applications for transfers from the White Earth Reservation; and,

WHEREAS, the following people are eligible due to their blood quantum and their ancestral background:

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17th day of April, 1997 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
