RESOLUTION 07-0 4-104-97

A RESOLUTION TERMINATING A LAND LEASE TO

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required for the purposes of a homesite, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs reservation, and;

WHEREAS, the Mille Lacs Band Assembly is responsible for all land lease agreements, etc, and;

WHEREAS, (Tract G) That part of the Southwest Quarter of Section 1, Township 42, Range 25, Mille Lacs County, Minnesota described as follows: Commencing at the northeast corner of the West half of the Northeast Quarter of the Southwest Quarter of said Section 1; thence North 88 degrees 38 minutes 44 seconds West, assumed bearing, along the north line of said Southwest Quarter 225.00 feet; thence South 01 degrees 21 minutes 16 seconds West 300.00 feet; thence South 88 degrees 38 minutes 44 seconds East 226.95 feet to the east line of the West half of the Northeast Quarter of the Southwest Quarter; thence North 00 degrees 58 minutes 53 seconds East along the east line 300.00 feet to the point of beginning.

Subject to road easement over the above described property which lies northerly of a line drawn from a point on the west line of the above described property therein distant 52.79 feet southerly of the northwest corner to a point on the east line of the above described property therein distant 53.18 feet southerly of the northeast corner. (Resolution 06-04-23-96)

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly terminates this land lease effective July 29, 1997.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29th day of July, 1997 at Vineland, Minnesota by a vote of 3_FOR, 0_AGAINST, 0_SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of Assembly to be affixed to this resolution and forwarded to the Chief Executive for Concurrence.
